### THE RAVEN CARD

Franklin Pierce College is pleased to offer the Raven Card, an exciting service utilizing the student identification card as a declining balance account. Your student ID will not only provide access to the dining hall, Pub/snack bar, but can also be used for purchases in the College bookstore.

To initiate the Raven Card, you simply deposit funds, in whatever amount you decide is appropriate, at the Bursar's Office prior to use. Each purchase made using the Raven Card will then be automatically deducted from your account, eliminating the inconvenience of cash, new checking accounts, or temporary loans on your credit card.

Thereafter, monies may be added and inquiries of the account balance may be made at any time.
